1. THE PRESIDENT'S CORNER:

On behalf of the Directors of the Association, I welcome you, our Members, friends and other readers, to this summer 2016 edition of *The Lampette*. We certainly hope that the summer is off to a good and safe start for all of you.

Unfortunately, 2016 got off to a sad start with the passing of COL Robert Braverman on 15 January and his funeral service on 20 January. COL Braverman was a true patriot, soldier and friend, and a Director Emeritus of the Association who will be sorely missed. During his long tenure on the Board, in 2000-2002 he was the Chairman of the 77th Infantry Division Expressway Committee, which was successful in obtaining the renaming of the Clearview Expressway in the borough of Queens, NY. He was also a key member of the World Trade Center Memorial Committee project which led to the dedication in November 2002 of the 77th Memorial Grove and its monument to the six soldiers of the 77th who lost their lives in the Twin Towers on 9/11/01. COL Braverman will be remembered during the Annual Ecumenical Memorial Service at Fort Totten on 6 November, along with other members of the 77th family who have passed-on this year.

Also, early in the year we were informed that CSM Sammy Sablan, the former CSM of the 77th Sustainment Brigade, was to retire in April, return to his home state of Texas and settle in the San Antonio area. We thank CSM Sablan for his loyal support as a member of the Association and an elected Director. While CSM of the Brigade, he constantly promoted the history of the 77th and personally ensured that the supporting elements of the Brigade were in the position of readiness during special ceremonies. SGM Sablan was also a featured speaker during a Commemoration Service in Central Park and at member meetings. We thank Sammy for his service and wish him and his family much continued success and good health in retirement.

One of the main topics which has been on the board's agenda during its meetings since January is the development of suitable recognition events for the 77th Infantry Division's 100th Anniversary which will occur in 2017. We have solicited ideas and requested assistance from a number of sources. Based on

the fact that we have limited resources, the current thinking is to plan according to our capabilities and relationships with the Active Reserve, primarily the 77th Sustainment Brigade and the 319th US Army Band; the 1st Battalion, 307th Regiment (Active Army); several other military organizations and the New York City Department of Veterans Services. We envision expanded memorial services in Central Park and Fort Totten, and possibly a second event at Fort Totten around the anniversary of the activation of the Division at Yaphank in August 1917. We will continue to be involved with this project for the balance of the year, and we would welcome your ideas, personal involvement and support. On 7 May I was accompanied by COL Edwin Logan, COL Ivan Cornielle and Mr. Malcolm Schade in representing the Association at the 77th Sustainment Brigade Change of Command Ceremony. BG Richard C. Staats, Commanding General, 316th Sustainment Command (Expeditionary) officiated during the ceremony when COL Deborah L. Kotulich relinquished command to COL Pamela L. McGaha. It is our understanding that COL Kotulich has been assigned to a general officer command in Orlando, Florida, where she will be promoted to BG later this year. It was a pleasure to know COL Kotulich and we sincerely appreciated her generous support of Association activities.

The Spring Luncheon took place at the Swan Club on 18 May and was very well attended. We were honored to have three Major Generals in attendance: MG George E. Barker, MG William S. Crupe and MG William Terpeluk. The luncheon provided the opportunity for those present to meet COL Pamela L. McGaha, the recently appointed Commander of the 77th Sustainment Brigade. COL McGaha briefed the attendees on the activities of the Brigade, including preparation and training for future missions. We were very pleased to welcome COL McGaha as a new member of the Association. We also were very pleased to welcome into membership LTC Ronald S. Willdigg. Both COL McGaha and LTC Willdigg were presented with the now traditional 77th wine glass and Association pin. Additional coverage of the meeting appears later in this issue of *The Lampette*.

On 19 May it was my pleasure to represent the Association at the United States Military Academy at West Point and present our Association's annual award for Excellence in National Security and Public Affairs to a graduating cadet. This award, which was established in 1970, was presented to Cadet Kevin M. Fidler this year. Cadet Fidler, who majored in International Relations and French, was to be commissioned in the Quartermaster Branch and will be assigned to the 2nd Cavalry Regiment and posted in Vilseck, Germany. He grew up in Woodbury, Minnesota. After the awards ceremony and presentation of the pewter tray, I also had the pleasure of meeting with Cadet Fidler's very proud parents.

2. FUND RAISING:

The 77th Infantry Division ROA is offering for sale 77th Infantry Division wine glasses and whiskey tumblers etched with the 77th "Liberty" patch. The glasses and tumblers are \$8 for one, \$15 for two, and for \$85 for a dozen. Shipping is included in the price for a dozen, but there is an additional charge of \$3.65 for shipping 1-4 glasses or tumblers, or \$14 for 5-11 glasses or tumblers.

77th Infantry Division baseball-type hats are available in various colors for \$15 each. Also available are Memorial Bricks, at \$125 each, installed in the 77th Memorial Grove at Fort Totten. Each brick can be inscribed with up to three lines, and each line can contain up to a total of 20 characters and spaces. 3. 77th SUSTAINMENT BRIGADE CHANGE OF COMMAND CEREMONY:

On 7 May 2016, COL Pamela L. McGaha assumed command of the 77th Sustainment Brigade, 316th Sustainment Command (Expeditionary), in a ceremony which was relocated from Sharpe Field to the Doughboy Gym at Joint Base McGuire-Dix-Lakehurst, NJ, due to inclement weather. The ceremony was held, under the regulations for outdoor ceremonies, in front of an assembly in formation of some of the Soldiers of the 77th SUS BDE.

The ceremony included the traditional transfer of the Brigade Colors from the Outgoing Commander, COL Deborah L. Kotulich, to COL McGaha. It also featured remarks by BG Richard C. Staats, Commander, 316th ESC; COL Kotulich, and COL McGaha. Detailed biographies of those officers, and a Statement of Service and description of Campaign Participation Credit of the 77th SUS BDE, appeared in the program for the ceremony.

6. 307th INFANTRY VETERANS SOCIETY:

With regret, decisions were made by our Association and the 307th Infantry Veterans Society to cancel the annual Commemoration Ceremony which had been scheduled by our organizations for Saturday, 11 June 2016 in the 307th Infantry Regiment Memorial Grove in Central Park, N.Y. The primary reason was conflicting assignments of major participants which would have reduced or precluded their ability to provide the level of support that we have enjoyed in the past. Because the Grove is in a highly visible location in Central Park, it was felt that it would be inappropriate to hold a program which would not meet the standards of our previous memorial services there. We will be scheduling a ceremony in the Grove during 2017, as part of the observances we are planning of the 100th anniversary of the organization at Camp Upton of the 307th Infantry Regiment and the 77th Infantry Division.

7. UPCOMING NOVEMBER MEMORIAL SERVICE AT FORT TOTTEN:

On 6 November 2016, the 77th Infantry Division Reserve Officers Association will hold its 40th Annual Memorial Service, to honor former 77th members who, in the past year, have answered the last roll call. Families of the deceased will receive invitations to the service, which will be held in the Fort Totten Chapel at 13:30 hours.

Upon completion of the service, all are invited to attend the annual wreath-laying ceremony in the 77th Memorial Grove, honoring the six Reserve Soldiers who lost their lives in the Twin Towers on 9/11/01. Refreshments will follow and all are invited to join us in the Ernie Pyle Reserve Center drill hall.

8. ASSOCIATION HISTORIAN:

Each issue of *The Lampette* features a 77th Medal of Honor recipient and their citation. The seventh in the series follows:

Corporal Desmond Thomas Doss, Sr., MOH passed away on 23 March 2006 in Piedmont, Alabama at the age of 87, and he was honored at our Annual Ecumenical Memorial Service at Fort Totten on 5 November 2006. After one year of high school, he went to work for a lumber company, and by March 1941 he was working as a ship joiner at the Newport News naval shipyard. A devout Seventh-day Adventist who was religiously opposed to bearing arms or taking human life, he nevertheless turned down the opportunity to receive a draft deferment for World War II based on his employment at the shipyard. After being classified 1-A-O and drafted at the age of 23 in April 1942 at his place of birth in Lynchburg, Virginia, he served with exemplary valor as an unarmed medic in the Medical Detachment (attached to Company B, 1st Battalion), 307th Infantry Regiment, 77th Infantry Division.

On 12 October 1945, when he was a Private First Class, he was awarded the Medal of Honor for his "conspicuous gallantry and intrepidity in action above and beyond the call of duty" from 29 April to 21 May 1945 at Urasoe Mura during the Battle of Okinawa, after having already been awarded two Bronze Stars in 1944 for actions with the 307th, at Guam and Leyte. He also earned three Purple Hearts, and was diagnosed with tuberculosis (which eventually cost him a lung and five ribs) shortly before leaving the Army in 1946. He was the first conscientious objector ever to be awarded the Medal of Honor.

The following is excerpted from the citation for his Medal of Honor (paragraph breaks inserted):

"...Private First Class Doss was a company aid man when the 1st Battalion assaulted a jagged escarpment 400 feet high. As our troops gained the summit, a heavy concentration of artillery, mortar and machinegun fire crashed into them, inflicting approximately 75 casualties and driving the others back. Private First Class Doss refused to seek cover and remained in the fire-swept area with the many stricken, carrying them one-by-one to the edge of the escarpment and there lowering them on a rope-supported litter down the face of a cliff to friendly hands.

On 2 May, he exposed himself to heavy rifle and mortar fire in rescuing a wounded man 200 yards forward of the lines on the same escarpment; and two days later he treated four men who had been cut down while assaulting a strongly defended cave, advancing through a shower of grenades to within eight yards of enemy forces in a cave's mouth, where he dressed his comrades' wounds before making four separate trips under fire to evacuate them to safety.

On 5 May, he unhesitatingly braved enemy shelling and small arms fire to assist an artillery officer. He applied bandages, moved his patient to a spot that offered protection from small arms fire and, while artillery and mortar shells fell close by, painstakingly administered plasma. Later that day, when an American was severely wounded by fire from a cave, Private First Class Doss crawled to him where he had fallen 25 feet from the enemy position, rendered aid, and carried him 100 yards to safety while continually exposed to enemy fire.

On 21 May, in a night attack on high ground near Shuri, he remained in exposed territory while the rest of his company took cover, fearlessly risking the chance that he would be mistaken for an infiltrating Japanese and giving aid to the injured until he was himself seriously wounded in the legs by the explosion of a grenade. Rather than call another aid man from cover, he cared for his own injuries and waited five hours before litter bearers reached him and started carrying him to cover. The trio was caught in an enemy tank attack and Private First Class Doss, seeing a more critically wounded man nearby, crawled off the litter; and directed the bearers to give their first attention to the other man. Awaiting the litter bearers' return, he was again struck, this time suffering a compound fracture of one arm. With magnificent fortitude he bound a rifle stock to his shattered arm as a splint and then crawled 300 yards over rough terrain to the aid station.

Through his outstanding bravery and unflinching determination in the face of desperately dangerous conditions Private First Class Doss saved the lives of many soldiers. His name became a symbol throughout the 77th Infantry Division for outstanding gallantry far above and beyond the call of duty."
