1. <u>THE PRESIDENT'S CORNER</u>:

On behalf of all of the directors of the Association, I welcome our members, friends and other readers to this issue of *The Lampette*. This issue inaugurates the publishing of an annual *Lampette* instead of separate spring and winter issues. While this is a departure from a 59-year tradition, the Board of Directors felt that it was appropriate to make the change. As years have gone by, we have been receiving increasingly fewer news items from our members, and social media and the internet are competing with the printed word. It is our intention to present a year's summary of Association activity with a December or January publication date. For those of you who desire more timely information, we invite you to visit our web site, which recently has been updated.

In preparation for 2017, and in recognition of the 100th Anniversary of the 77th Infantry Division, an attractive challenge/commemorative coin was developed for permanent remembrance of this special occasion, or for ongoing use. The coins have been made available for sale on our web site and during Association activities. We still have a number of them available for sale.

The Anniversary year was kicked-off by the 77th Sustainment Brigade at Fort Dix on 7 April when most of the Brigade's Soldiers were present. COL Pamela L. McGaha, Commander, and LTC(P) Thomas P. Sullivan, Deputy Commander, hosted the event. A number of directors and members were in attendance. MG William Terpeluk and I spoke about the history of the Division and the activities of the Association.

The Spring Luncheon was held on 10 May at the Swan Club, when the Anniversary was celebrated with a special cake arranged for by SGM Tony Filosa, chairman of the luncheon. COL Gerard A. McEnerney and CSM Daniel J. Mari were welcomed into membership, and COL Seymour Kaplan and CW4 Bernie Kaplan conducted the customary raffle of donated gifts, the proceeds of which go to the Memorial Fund.

On 25 May, I attended the annual Awards Ceremony at the United States Military Academy at West Point, and was pleased to present our Association's award of a pewter tray to then Cadet Patrick W. Dancer. The award is presented to the graduating cadet who achieves the highest standing in courses relating to National Security and Public Affairs.

The annual Commemoration Ceremony in the 307th Infantry Regiment Memorial Grove in Central Park was held on 10 June. The ceremony was supported by the 77th Sustainment Brigade and the 319th U.S. Army Band. The 389th Combat Sustainment Support Battalion, a unit of the Brigade under the command of LTC Kevin S. McGuire and CSM Carol A. Cox, provided the Color Guard and the required logistical support, including seating and a public-address system. A provisional battalion of soldiers from the Brigade also were in attendance. The event had PAO coverage by the Office of the Chief, Army Reserve, represented by LTC Eric M. Nager, USAR, and by the 77th Sustainment Brigade, represented by SSG David H. Clemenko.

The speakers during the ceremony were Ms. Caroline Greenleaf, Director of Community Relations, Central Park Conservancy; Mr. Oswaldo M. Pereira, Community Outreach Manager, NYC Department of Veteran's Services; MG William Terpeluk, MG Evo Riguzzi, Jr.; COL Edwin G. Logan and LTC(P) Thomas P. Sullivan. The 319th Band under the direction of SFC Patricia Flowers provided outstanding musical support. In recognition of the 100th Anniversary, they performed a medley of songs from the WWI and WWII eras and a vocal rendition of *God Bless the USA* by SSG Joseph M. Young.

The Armed Forces Reserve Family Assistance Fund held its 17th Annual MG Frank Donohue Golf Outing at the West Point Golf Course on 14 August. A number of our members attended this event, which raises funds to support emergency needs of families of USAR soldiers who are on active duty.

The 77th Sustainment Brigade held its Annual Dining Out at Fort Dix, NJ. It was hosted by COL McGaha and LTC(P) Sullivan, both of whom did an outstanding job in recognizing the 100th Anniversary of the 77th Infantry Division. Mr. Robert Laplander, author and historian of the "Lost Battalion," was the principal speaker. COL Ed Logan, Mr. Malcolm R. Schade and I represented the Association.

The Association's Fall Luncheon and Annual Meeting was held on 18 October at the Swan Club. During the business portion of the meeting, the slate of directors that had been previously presented to the membership was elected. The Treasurer's Report was presented on behalf of COL Logan in his absence by Mr. Schade, as assistant treasurer, and I reported on the activities that had taken place since the first of the year.

On 5 November, the 41st Annual Memorial Service was held at the Fort Totten Chapel, where fifteen members of the 77th family were honored, including a director emeritus, COL Martin Dawson, who passed in January, and director CW4 Edward C. Grant, who passed in April. COL Dawson was a past president of the Association, served on the original memorial committee with his wife Renée, and was the long-time chair of the meetings committee until he could no longer participate due to health reasons. COL Dawson was a veteran of WWII, a former commander of the 77th Signal Battalion, 77th Infantry Division, and was Deputy Chief of Staff Intelligence, 77th USARCOM, at the time of his retirement.

CW4 Grant transferred from the National Guard to the Army Reserve in 1970, where he enjoyed dual status as a Sergeant and Military Technician in the Adjutant General Section of the 77th USARCOM. He subsequently was commissioned Warrant Officer and served in the Public Affairs office until his retirement. CW4 Grant had several nick-names. While serving on our Board of Directors, he was referred to as "Flagman," as he was the custodian of the Association's flags, including those of the General officers. Ed and his wife, Kathy, ensured that the appropriate flags and banner were positioned during our memorial services, meetings and other events, including out-of-town ceremonies.

The principal speakers during the service were: MG Troy D. Kok, Commanding General, 99th Regional Support Command, where he is responsible for all logistics and facilities support for more than 40,000 Army Reserve installations across a region spanning thirteen northeastern states; MG Anthony R. Kropp (Ret), Former Commander of the 411th Engineer Brigade and a member of the Association; and COL Pamela L. McGaha, Commander, 77th Sustainment Brigade. LTC(P) Thomas P. Sullivan was the principal speaker during the Wreath Laying Ceremony in the 77th Memorial Grove, where the six Soldiers who were lost on 9/11 were remembered and honored.

During the reception that took place after the memorial services, we rededicated Kaine Hall during a brief ceremony. As you know, MG John W. Kaine, who passed away in 1995, was the last Commanding General of the 77th Infantry Division (1958-1965) and the first Commander of the 77th US Army Reserve Command (1967-1972). General Kok delivered eloquent remarks about the history of the 77th and focused on the 77th Medal of Honor recipients in WWI and WWII, whose plaques are on display. Colonel McGaha spoke about the relevance of displaying the 77th unit crests and memorabilia in the hall that soldiers assigned to units of the 77th Sustainment Brigade use during battle drills, meals and other activities. Before the Prayer of Dedication, CH (LTC) Murray Stadtmauer shared some personal recollections about General Kaine.

As most of you know, the replacement of General Kaine's portrait which had gone missing, and the reinstallation of his memorabilia which had been removed due to building renovations, were on the Association's drawing board for many years. While the chair rails with display cases have been in place, their fronts were undecorated and we were in need of unit crest images which for the most part do not exist in official archives. Early in the year, we had the good fortune to locate, within our own resources, original paintings of the unit crests of the major units which were organically assigned to the 77th Division when it was deactivated in 1965. Mr. Schade was able to have the crests reproduced to size and mounted in wooden and plexi-glass frames, and to replace the lost portrait of General Kaine based upon a photographic negative. LTC Joseph Schroder installed the unit crests and picture of General Kaine, and relocated the Medal of Honor plaques from a corridor outside the hall.

We still have some specific unmet needs in the Kaine Hall display for shoulder epaulet unit pins, branch insignia and other small (maximum height of 5/8 inch) items for addition to the locked, glass-covered shelves over the new framed unit crests, for the following 77th units: 308th Infantry, 302nd Engineers Battalion, 302nd Medical Battalion, 77th Transportation Battalion, 77th Signal Battalion, 304th Field Artillery Battalion, 305th Field Artillery Battalion, 306th Field Artillery Battalion and 902nd Field Artillery Battalion. (We also could use a pair of branch insignia for the 306th Infantry.) If any of our readers would be willing to donate any of these items, please send them by U.S. Mail to our post office box address above in the masthead of this newsletter. (FedEx and UPS will not deliver to post office boxes.) Items that can't be used in the Kaine Hall exhibit will be offered to the 77th Sustainment Brigade for display in their headquarters at Fort Dix, New Jersey.

2. 2016 9-11 REMEMBRANCE CEREMONY AT FT. TOTTEN:

On 11 September 2016, a Remembrance Ceremony hosted by COL Michael G. 7. 2017 CENTRAL PARK CEREMONY:

On 10 June 2017, the 77th Infantry Division Reserve Officers Association, in conjunction with the 307th Infantry Veterans Society, held their annual Commemoration Ceremony in the 307th Infantry Regiment Memorial Grove, in Central Park. The ceremony honored all service members who have lost their lives defending our country, with particular emphasis on Soldiers of the 307th Infantry Regiment, 77th Infantry Division, who died during World War I and World War II. An additional theme this year was the special observance of the 100th Anniversary of the organization of the 77th Infantry Division at Camp Upton, New York in 1917.

The Commemoration Ceremony and 100th Anniversary Observance on 10 June was introduced and led by COL Louis H. Sudholz, Jr., President of the 77th Infantry Division ROA. The Invocation, Prayer and Benediction were offered by CH (MAJ) Edward V. Paul, USAR, Chaplain, 77th Sustainment Brigade.

The first guest speaker was Ms. Caroline Greenleaf, Director of Community Relations, Central Park Conservancy. Her remarks focused on the significance of the 307th Infantry Regiment Memorial Grove for Central Park. The second guest speaker was Mr. Oswaldo Pereira, Community Outreach Manager, New York City Department of Veterans' Services. His remarks emphasized the importance of supporting veterans and remembering those who sacrificed their lives in the service of their country.

The first of two keynote speakers was MG William Terpeluk, Former Commanding General, 77th Regional Readiness Command. His remarks recalled the history of the 77th Infantry Division, covering both its organization in New York in 1917 and heroism during WWI, including the story of the so-called "Lost Battalion" in the Argonne Forest of France, and also the Division's distinguished service in the Pacific Theater during WWI.

The second keynote speaker was MG Evo Riguzzi, Jr., Former Deputy Commanding General, United States Army Reserve Training and Doctrine Command. His remarks focused on the reorganization of the 77th after WWII as a US Army Reserve Command and the participation of successor units in Operations Desert Storm and Desert Shield.

The next speaker was LTC(P) Thomas P. Sullivan, USAR, Deputy Commander, 77th Sustainment Brigade, who spoke about the Brigade's ongoing mission to carry on the proud legacy of the 77th Statue of Liberty Patch.

Remarks about the history of the 307th Infantry Regiment in both World Wars and its role in the establishment and support of the Memorial Grove in Central Park beginning in 1920 to the present were delivered by COL Edwin G. Logan. COL Logan also introduced the placing of the memorial wreath by COL Lawrence M. Bellman; CSM Carol A. Cox, USAR, 389th Combat Sustainment Support Battalion; and SGM Anthony A. Filosa, Former Command Sergeant Major, 306th Military Police Brigade.

Supporting the ceremony throughout were members of the 389th Combat Sustainment Support Battalion Color Guard, and the 319th U.S. Army Band, led by SFC Patricia Flowers, USAR. In addition, the ceremony was attended by numerous Soldiers of the 77th Sustainment Brigade, who assisted with the equipment and preparations, and who represented the USAR to the community by their presence.

9. 2017 FALL LUNCHEON AND ANNUAL MEETING:

On 18 October 2017, our Association held its Fall Luncheon and Annual Meeting at The Swan Club in Roslyn, New York. Enjoying favorable weather, the event was attended by 20 members and nine spouses and guests. As usual, the schedule began with a cocktail reception with passed hors d'oeuvres, which were followed by a served luncheon.

During the luncheon, President Lou Sudholz conducted a brief business meeting, and reported regarding recent Association activities, plans for the rest of the year, and events planned for 2018. As is customary, he began by recognizing the General Officers who were present: MG George E. Barker and MG Anthony R. Kropp, and he also recognized the following former 77th Command Sergeant Major and Sergeants Major who were present: CSM Daniel J. Mari, SGM Anthony A. Filosa and SGM Leonard Finkelstein. He also noted the passing away of a former president and long-time director of our Association, COL Martin Dawson, in January, and of our director, CW4 Edward C. Grant, in March.

Mr. Malcolm R. Schade, as assistant treasurer, summarized the Treasurer's Report prepared by COL Edwin G. Logan, who was unable to attend the meeting. Mr. Schade reported in some detail regarding the largest single expenditure of the year, which consisted of the production of 14 framed unit crests and insignia of organic units of the 77th Infantry Division, and a framed photographic portrait of MG John W. Kaine. In early October 2017, these unit crests were installed by LTC Joseph Schroder on the fronts of the chair rails in Kaine Hall in the Ernie Pyle USAR Center, Fort Totten, and the portrait was mounted on the wall above them. In addition, some personal memorabilia of General Kaine and other items have been installed in the chair rail display cases, and the Association plans to supplement those items in the future, to complete the long-planned decoration of the south wall of Kaine Hall.

Mr. Schade, as secretary, and CW4 Bernard M. Kaplan then conducted the election of directors. Based upon the presence in person of 20 voting (Regular or Honorary) members, augmented by numerous proxies given prior to the meeting, the meeting more than achieved the required quorum of at least 20 voting members (10% of the total number of members eligible to vote). All of the candidates proposed by the Nominating Committee were elected for the respective terms described in the proxies and ballots, and until their successors shall be duly elected and qualified.

10. 2017 ANNUAL ECUMENICAL MEMORIAL SERVICE AT FT. TOTTEN:

On Sunday, 5 November 2017, the 77th Infantry Division Reserve Officers Association held its 41st Annual Ecumenical Memorial Service in the Post Chapel at Fort Totten. This Memorial Service specifically remembers Soldiers of the 77th Infantry Division and its successor units, as well as other veterans who have been long-time friends of our Association, whose passing has come to the attention of the Association during the preceding year. Since 2005, these Soldiers have specifically included members of the 307th Infantry Veterans Society. In addition, the Memorial Service honors all other members of the 77th family who have served and currently are serving their country. We were pleased that the Memorial Service in the Chapel this year was attended by an especially large number of family members and friends, many of whom traveled considerable distances, of the Soldiers being remembered, as well as by many members and other guests of our Association. Immediately following the Memorial Service in the Post Chapel, our Association held its 15th Annual Wreath Laying Ceremony at the 77th Memorial Grove next to the Ernie Pyle USAR Center, Fort Totten.

This year, the customary Reception for participants and other attendees held immediately afterwards in the MG John W. Kaine Memorial Hall, on the first floor of the Ernie Pyle USAR Center adjacent to the Memorial Grove, was expanded to include two additional events. The first of these was an observance of the 100th Anniversary of the organization of the 77th Infantry Division at Camp Upton, New York in 1917. The second additional event was a rededication of Kaine Hall following the installation by our Association in October of 14 new, framed unit crests and insignia of organic units of the 77th Infantry Division and a framed replacement portrait of General Kaine, and the re-installation of a display of some of his personal memorabilia. Also re-installed were 15 individual bronze plaques honoring the 77th Soldiers who were awarded the Medal of Honor during WWI and WWII.

The Service began with the posting of the colors by a Color Guard of the 3rd Brigade, 100th Training Division. This was followed by a welcome by our President, COL Louis H. Sudholz, Jr., who also introduced the other participants and read the Last Roll Call. His introductory remarks were immediately followed by the Pledge of Allegiance led by LTC John W. Peterkin, and the singing of the National Anthem by the Congregation.

The Invocation and Scripture Reading were offered by CH (LTC) Murray E. Stadtmauer (Ret), who is a long-time member and supporter of our Association. The Prayer and Benediction were offered by CH (1LT) Nafatara Sugrim, USAR, Chaplain, 389th Combat Sustainment Support Battalion. Dr. Pam Phillips accompanied herself on the piano and sang *Ave Maria* and *The Lord's Prayer*, in addition to playing a Piano Prelude and Postlude.

Remarks regarding the proud history of the 77th from the beginning in 1917 and its significant role in both World Wars, including several important battles and the 15 Medals of Honor awarded to its Soldiers during that period, were delivered by MG Troy D. Kok, USAR, Commanding General, 99th Regional Support Command.

The Keynote Speaker was MG Anthony R. Kropp (Ret), Former Deputy Chief of Engineers, who is a long-time member and supporter of our Association. His Remarks focused on the dedication of Soldiers when they take their oaths upon enlistment, and then related several of his personal experiences during his distinguished 35-year military career, first as an enlisted Soldier in 1967 and later as an officer.

Remarks regarding the importance of honoring the members of the 77th who have passed on, the history of the Division and its 100th Anniversary, and the role of the present 77th Sustainment Brigade in carrying on the traditions of the Division, were delivered by COL Pamela M. McGaha, USAR, Commander, 77th Sustainment Brigade.

Eulogies of the following departed members of the 77th family were delivered by COL Lawrence M. Bellman: COL Harold G. Beal, Jr.; SGT James Cox, COL Martin Dawson, COL Joseph P. Dunne, LTC Timothy G. Dyas, LTC Harry S. Figman, SGT Gordon W. Gibson, CW4 Edward C. Grant, COL John Michael Murphy, LTC Howard E. Nankervis, Jr.; CW3 Donald A. Patane, COL Carmine J. Perrotta, MAJ Frank M. Pinto, LTC James H. Vander Velde and COL Peter Frank Zullo. Personal remarks by other participants, and by seven family members and friends who were among the Congregation, supplemented six of the eulogies. In addition, a prayer for all the departed Soldiers was offered by Sister Hannah Cox, Presentation Sisters. She is the surviving daughter of SGT James Cox, a WWI veteran who was among the 77th Soldiers who were remembered. A Trumpeter of the 319th U.S. Army Band, SGT Joseph P. Naples, USAR, rang a chime and played TAPS during the Last Roll Call.

Despite intermittent rain, numerous members of the Congregation from the Memorial Service then attended the Wreath Laying Ceremony in the 77th Memorial Grove. Another posting of the colors by the Color Guard was followed by brief Introductory Remarks by COL Sudholz.

LTC(P) Thomas P. Sullivan, USAR, Deputy Commander, 77th Sustainment Brigade, then delivered Remarks regarding the significance of the Grove and the sacrifice of those six Soldiers on 9-11-2001.

Chaplain Stadtmauer offered a Prayer for Soldiers and Chaplain Sugrim offered a Prayer of Remembrance. COL Bellman and CW4 Bernard M. Kaplan presented the Memorial Wreath. Dr. Phillips led the attendees in singing *God Bless America*, and SGT Naples played TAPS.

Immediately after the Wreath Laying Ceremony in the 77th Memorial Grove, all participants and attendees were invited to Kaine Hall for the 100th Anniversary Observance, the Rededication Ceremony and an informal Reception, with refreshments. Brief additional Remarks regarding the Anniversary and the Rededication were delivered by COL Sudholz, MG Kok, COL McGaha and Chaplain Stadtmauer. COL Sudholz and Chaplain Stadtmauer included some personal reminiscences of MG Kaine.

11. VETERANS DAY AT BROOKHAVEN NATIONAL LABORATORY:

MG William Terpeluk (Ret) attended a Veterans Day Ceremony at Brookhaven National Laboratory on 9 November 2017 at the invitation of the Brookhaven Veterans Association. This ceremony also marked the centennial of the establishment of Camp Upton as the World War I mobilization and training center for the 77th Division. The BVA has traditionally been very supportive of numerous related efforts of the 77th, most notably the Casing of the Colors ceremony of the 77th Regional Readiness Command in September 2008. Mr. Donald Farnam of BNL, a good friend of the 77th, coordinated the activities for this extremely notable Veterans Day commemoration.

The event was attended by Dr. Doon Gibbs, Director, Brookhaven National Laboratory; Dr. Robert Tribble, Deputy Director for Science and Technology; and Mr. Jack Anderson, Deputy Director for Operations. The ceremony included a Presentation of a Memorial Wreath, Commemoration of the Camp Upton Memorial Plaque, and Presentation of the American Flag. Several World War II veterans were in attendance, and were honored as part of the ceremony. The participation by the BNL community-at-large was very much in evidence.

BNL also provided a tour of the installation and surrounding area. Although Camp Upton was largely torn down just after World War I (only to be rebuilt during World War II), many features of the original post have been preserved or remain fairly intact. The history of Camp Upton still serves as a vital part of our tremendous legacy.

12. TREASURER'S REPORT:

During fiscal 2017, total expenses exceeded total revenues by \$2,530.38, compared with an excess of total revenues over total expenses of \$1,201.58 during fiscal 2016, despite our mostly successful efforts to control recurring expenses. This negative operating result in fiscal 2017 was primarily because we experienced significantly increased expenditures in two non-recurring categories. The first of these categories was an expanded Memorial Service in Central Park on 10 June, which included an observance of the 100th Anniversary of the organization of the 77th Infantry Division in 1917.

The second of these categories was the completion of our long-desired permanent display, consisting of fourteen framed images of 77th organic unit crests, for installation on the fronts of the chair rails, and the replacement of a framed portrait of MG John W. Kaine, in Kaine Memorial Hall. Although these and other, already-existing items were installed in Kaine Hall in October, which was during fiscal 2018, the framed unit crests and portrait were purchased during fiscal 2017. The final costs of materials for this project exceeded what we have received over the years in donations honoring General Kaine, and necessitated using some operating funds.

As you might note, we experienced a reduction in our expenses for postage and printing, due in part to an increased use of email. We continue to utilize e-mail, wherever possible, in an effort to reduce or at least restrain this category, and urge any members who have not yet provided or updated their e-mail address to please do so.

During fiscal 2018, we anticipate returning to a more normal level of expenditures, although we did incur increased expenses in connection with an expanded Memorial Service at Fort Totten on 5 November, which also included an observance of the 100th Anniversary and a Rededication Ceremony in Kaine Hall.

Although we will manage expenses carefully, we continue to foresee the need to count upon the generosity of our loyal membership to maintain our financial stability. Since we do not assess annual dues, donations play a significant role in our ability to maintain our organization and we would greatly appreciate all financial assistance, regardless of the amount provided. Please note that the reported donations for fiscal 2017 do not include any of the amounts which we have received in response to my letter dated 15 November 2017, for which we are very grateful.
