1. THE PRESIDENT'S CORNER:

The second half of the year brought some interesting opportunities and challenges for the Association. The following are highlights of the various events and activities which took place and are being covered in greater detail in the body of *The Lampette*.

In mid-August a delegation led by MG George Barker spent a day at Fort Dix, NJ visiting the 77th Sustainment Brigade where we observed the brigade being involved in a training exercise, Operation Sustainment Warrior.

On 19 August a number of members participated in the 13th Annual MG Francis T. Donohue Golf Tournament at West Point. This tournament, which is sponsored by the Armed Forces Reserve Family Assistance Fund and chaired by MG Evo Riguzzi, Jr., raises money to assist families of Reserve soldiers on active duty who are in serious need of immediate financial assistance.

September brought with it the passing of our beloved MSG Mary Lou Bornmann, the Editor of *The Lampette*, Member and Recording Secretary of the Board of Directors, and long-time member of the Association and the 77th family.

The shut-down by the government had its effect on several planned activities. MG Glenn Lesniak, US Army Reserve Command Deputy Commanding General-Support, was scheduled to attend our Annual Meeting on 16 October and comment on current Army Reserve programs. Unfortunately, his travel itinerary had to be cancelled. Likewise, the 77th Sustainment Brigade's Annual Dining Out had to be cancelled.

The Association's Annual Meeting, an evening function, was held at the Swan Club and was very well attended. It was good to have a number of general officers and their ladies with us, including MG George E. Barker, MG and Mrs. Anthony Kropp, MG Evo Riguzzi and BG and Mrs. Robert J. Winzinger, Sr. The guest speaker for the evening was Commissioner Terrance C. Holliday, New York City Mayor's Office of Veterans Affairs. Commissioner Holliday is a retired Colonel in the USAF.

The election of directors followed a review of second half-year Association activities. The slate of directors was approved by the voting members who were present. We are pleased to announce that MG William Terpeluk has returned to the East Coast and was elected to the board at the meeting.

In addition, SGM Anthony A. Filosa and CW4 Bernard M. Kaplan were elected earlier this year to fill vacant terms which will be expiring in 2014. These three bring with them a great deal of knowledge of the 77th and possess special skill sets which will strengthen our board of directors.

At the conclusion of Commissioner Holliday's presentation, he was welcomed to honorary membership in the Association, in recognition of his service to the veteran community. As is our custom, he was presented with a 77th Infantry Division ROA lapel pin and an engraved wine glass. The following additional individuals were welcomed into membership and presented with lapel pins and wine glasses: MG Anthony Kropp, COL John E. Wohrle and SGM Leonard A. Storz. COL Kenneth Storz accepted the pin and glass for his father, who is now residing in Florida.

Our 37th Annual Memorial Services were conducted at Fort Totten on 3 November in both the Chapel and the 77th Memorial Grove. MG George Barker and Commissioner Terrance C. Holliday spoke during the service in the Chapel and LTC Thomas P. Sullivan and Congressman Steve Israel spoke in the Grove. The Services were very well attended by the families of our deceased comrades, members and guests of the Association. COL Seymour Kaplan and his committee are commended for ensuring that all of the arrangements went smoothly. Details of the services appear separately.

Also on 3 November, the 99th Regional Support Command had a change of command ceremony at Fort Dix, NJ. Major General William D. R. Waff has been succeeded by MG Margaret W. Boor. We thank General Waff for his support of our Association's activities during the three years of his tenure. We look forward to welcoming General Boor and extending invitations for her to participate in our various functions.

Please join me in a special welcome to BG Bob Winzinger, who is now the fourth Editor of *The Lampette*. Previous Editors were LTC Eugene McConnell, BG Harry J. Mott, III and MSG Mary Lou Bornmann. The best way for everyone to assist General Winzinger is to contribute articles for *The Lampette*, which has been published continuously since 1957. Let us know what you are doing these days: vacations, trips, and -- if still active -- what's going on in your units, etc. Let's not allow the "social media" to replace the long-standing personal touch of *The Lampette*.

Looking ahead to the 2014 calendar of events, we are planning on having the Mid-Winter Meeting, an evening affair, on Wednesday 19 March. We are considering a location more central to Queens which might be more convenient to members traveling longer distances. Details will be announced after the New Year.

3. ANNUAL MEETING AND FALL DINNER:

The 77th Infantry Division ROA Annual Meeting and Fall Dinner were held at the Swan Club on 16 October 2013. All of the 54 attendees enjoyed the Swan Club's open bar and a sumptuous dinner. COL Sudholz opened the dinner program with a brief Association update including a description of plans and activities for the upcoming year.

COL Logan then gave a brief Treasurer's report, which was positive with income and expenses balancing out. 4. MSG MARY LOUISE BORNMANN:

It is with great sadness that we announce the death on 14 September 2013 of MSG Mary Lou Bornmann, who at the time was serving as a member of our Association's Board of Directors and Editor of our biannual newsletter, *The Lampette*.

Mary Lou entered the Women's Army Corps in 1970, and in 1975 reenlisted in the US Army Reserve. Her first assignment was with the 1174th Transportation Terminal Unit, where she served for 10 years culminating as Team Leader of the Operations Division. In 1985 she joined HQ, 77th Army Reserve Command, where she served in the Office of Public Affairs. There, as Non-commissioned Officer in Charge, Mary Lou spearheaded military participation in local and city and state public events. She also served as a journalist and spokesperson for the command during Operation Desert Storm and Operation Iraqi Freedom. A First Place Keith L. Ware Award winner for journalism, she also served as Editor of the Command Magazine, *The Liberty Torch*. She retired from the USAR in 2005. Already a long-time supporter of our Association, Mary Lou served as our Executive Administrator from 2009-2011, and as a member of the Board since 2011. She had been Editor of *The Lampette* since 2011.

Mary Lou's funeral at St. Hedwig's R. C. Church in Floral Park, NY on 16 September 2013 was attended by many members of her extended family of eight surviving siblings and 24 nieces and nephews, and by many of her former colleagues from the USAR and our Association, as well as other friends. Following that service, a procession of cars three blocks long followed the hearse to Holy Rood Cemetery in Westbury, NY, where a Color Guard and an Honor Guard, provided by the 11th NY Regiment, US Volunteers and the 99th RSC Casualty Affairs Office, were waiting. MG William Terpeluk, with whom Mary Lou had served when he was Commanding General of the 77th Regional

Readiness Command, presented to her family the American flag which had draped her coffin. The 77th Infantry Division flag was also on display during the graveside ceremony.

Too lengthy to quote here, and missing some of its text due to age, the article recounted the exploits of the 77th Infantry Division in the Pacific Theatre from Guam (where it says the 77th earned the sobriquet "butchers of Guam" from Tokyo Rose), through Leyte, Kerama Retto and Ie Shima, and on to "Chocolate Drop Hill" and "Sugar Loaf Hill" in Okinawa. Thank you, Sergeant, for this informative addition to our records. We wish you good luck in your new home!

We heard over the summer from the daughter of **SGT Edmund J. Hinkelmann**, a member of the 307th IVS who served during WWII in Co. B of the 305th Infantry Regiment (which was attached to the 307th). She wrote that her father recently had been admitted to a nursing home at the age of 92, due to poor health. However, she said that she reads *The Lampette* to him and that they both enjoy it. She also enclosed a poem of unknown authorship about the 77th in WWII, which she recently found among his military papers. It appears elsewhere in this issue. We hope that you enjoy this and future issues, and that your health improves!

SGT Henry A. Kokojan, a member of the 307th IVS who served during WWII in Companies K and I in the Pacific Theatre, passed away in Irving, Texas on 16 March 2013. He received a Purple Heart and the Bronze Star for his actions during the Battle of Okinawa. SGM Leonard A. Storz, a veteran of WWII who served in the 77th from 1948 to 1965, and thereafter in the 77th ARCOM until the mid-1980s, wrote us from his home in Florida. He expressed his appreciation for *The Lampette*, and confessed to "waxing nostalgic" while reading it. He added: "Please extend my congratulations and regards to Tony Filosa. I have fond memories of our serving together." **SGM Anthony A. Filosa** was elected to our Board of Directors earlier this year. Leonard is the father of **COL Kenneth P. Storz**, who recruited his father as a member of our Association in 2012.

BG Bob Winzinger is extremely proud of his fourteen-year-old grandson, Camron Winzinger, who recently became the youngest Eagle Scout in Rockland County in over twenty years. He also recently returned from a vacation in Hawaii where he attended the West Point versus University of Hawaii football game at Aloha Stadium (yes, we lost again, 49-42) and visited Ernie Pyle's grave in the Punchbowl National Cemetery.

6. ASSOCIATION HISTORIAN:

Each issue of *The Lampette* features a 77th Medal of Honor recipient and their citation. The second in the series is Medal of Honor recipient, George Benjamin, Jr. Rank and organization: Private First Class, U.S. Army, Company A, 306th Infantry, 77th Infantry Division. Place and date: Leyte, Philippine Islands, 21 December 1944. Entered service at: Carneys Point, New Jersey. Birth: Philadelphia, Pennsylvania.

Citation: "He was a radio operator, advancing in the rear of his company as it engaged a well-defended Japanese strong point holding up the progress of the entire battalion. When a rifle platoon supporting a light tank hesitated in its advance, he voluntarily and with utter disregard for personal safety left his comparatively secure position and ran across bullet-whipped terrain to the tank, waving and shouting to the men of the platoon to follow. Carrying his bulky radio and armed only with a pistol, he fearlessly penetrated intense machinegun and rifle fire to the enemy position, where he killed 1 of the enemy in a foxhole and moved to annihilate the crew of a light machinegun. Heedless of the terrific fire now concentrated on him, he continued to spearhead the assault, killing 2 more of the enemy and exhorting the other men to advance, until he fell mortally wounded. After being evacuated to an aide station, his first thought was still of the American advance. Overcoming great pain he called for the battalion operations officer to report the location of enemy weapons and valuable tactical information he secured in his heroic charge. The unwavering courage, the unswerving devotion to the task at hand, the aggressive leadership of PFC Benjamin was the source of great and lasting inspiration to his comrades and was to a great extent responsible for the success of the battalion's mission."

7. POTPOURRI:

We'll fight for Uncle Bruce And cover him with fame--We're the boys of the 77th We earned ourselves a name.

When MacArthur left the Philippines He said he'd be back or rot; But he ran into a stalemate And things didn't go so hot.

He called the 77th
And hell began to crack.
We hit them on December 7th-Pearl Harbor Day, in fact.

Now we're waiting for the bugle call To line us up for Reveille And tell us we're going back To our homes across the sea.

We'll march down Fifth Avenue--The people will cheer and call "They're Bruce's Bathless Bastards, The heroes of them all!""

8. <u>ANNUAL ECUMENICAL MEMORIAL SERVICE</u>:

Our Association held its 37th Annual Ecumenical Memorial Service on 3 November 2013 in the Post Chapel at Fort Totten. Family members, comrades and friends of those honored filled the chapel to near capacity.

Our president, COL Louis H. Sudholz, Jr., led the ceremony. Our distinguished speakers in the chapel included COL Terrance C. Holliday, USAF, Commissioner, New York City Mayor's Office of Veterans' Affairs, who also read a letter from Mayor Michael R. Bloomberg, and MG George E. Barker, Former CG, 77th ARCOM. The eulogies for members of the 77th were given by MSG Jeffrey J. Mott, while COL Edwin G. Logan, President of the 307th Infantry Veterans Society, did the same for those who had been members of the 307th Infantry Regiment.

Our Association is extremely grateful to Dr. Pam Phillips for her many years of volunteering to support this event. Her piano playing and beautiful singing of "Ave Maria" and "The Lord's Prayer" in the chapel, plus "God Bless America" at the 77th Memorial Grove, were greatly appreciated by all in attendance.

A scripture reading by CHAP (LTC) Murray E. Stadtmauer and a prayer by CHAP (LTC) Ephraim Garcia were very appropriate for the occasion and the congregation listened intently. The Color Guard from the 389th CSSB (77th Sustainment Brigade) and the Bugler from the 319th US Army Band performed their duties in a professional and outstanding manner, greatly enhancing the service.

Immediately following was the 11th Annual Wreath Laying Ceremony in the 77th Memorial Grove, next to the Monument honoring six soldiers of the 77th Regional Readiness Command who lost their lives at the World Trade Center on 9/11/2001. After introductory remarks by COL Sudholz, the first speaker was LTC Thomas P. Sullivan, himself a survivor and rescuer at the WTC, who described the six soldiers whose names are on the Monument. Next was U.S. Representative Steven J. Israel (N.Y. 3rd District), who spoke movingly about their sacrifices and the importance of remembering them, and all others who have served their country in uniform. Following a prayer by Chaplain Stadtmauer, a memorial wreath donated by our Association was presented at the Monument by COL Allen J. Nadler and LTC James S. Taylor.

BG Robert J. Winzinger, Sr. then conducted a ceremony dedicating a new memorial bench next to the Monument in honor of COL Eileen M. Bonner, a member of our Association who served in the 8th Medical Brigade and was the first and only female President of the national Reserve Officers Association, among many other distinctions. Also participating was COL Ed Wutzer, former Chief of Staff, 8th Medical Brigade.

After this bench dedication, a prayer was offered by Chaplain Garcia, Dr. Phillips led those in attendance in singing "God Bless America", and the Bugler played TAPS.

Immediately following these ceremonies, our Association held an informal reception with light refreshments, to which all of the participants and attendees were invited, at Kaine Hall, Ernie Pyle USAR Center, adjacent to the 77th Memorial Grove.

12. CHANGE IN RETIRED USAR FORMS OF ADDRESS:

On 17 May 2013 (effective 17 June 2013), General Raymond T. Odierno, United States Army Chief of Staff, issued a "major revision" of Army Regulation 25-50 ("Preparing and Managing Correspondence"), which is applicable to the Active Army, the Army National Guard and the U.S. Army Reserve. Among the changes are explicit instructions standardizing the form of address and signature blocks on correspondence for all retired military personnel. These instructions are intended to put retired Reservists on equal footing with soldiers who retired from active duty, especially regarding the use of the Service abbreviation "USA" instead of the older form "AUS". Apparently, previously published reports of this change may have been in error regarding retired Reservists.

Revised paragraph 6-6 ("Retired military personnel") of AR 25-50 now reads as follows: "Retired military should follow the same rules as active personnel, except that no organization or branch of the Army will be shown. Show retired status after the grade as follows:

- a. All Army personnel, active or reserve component, retired for service, age, or physical disability and all personnel on the Army of the United States Retired List, including regular Army personnel and nonregular Army personnel on the Temporary Disability Retired List will use 'USA Retired' (for example, A. B. Smith, COL (USA Retired)).
 - b. All personnel on the Officers Honorary Retired List will use 'U.S. Army Retired (Hon).'
- c. All Army reservists assigned to the U.S. Army Reserve (USAR) Control Group (Retired) will use 'USA Retired.'
- d. Army retirees serving as DA civilians will not use or refer to their military grade or rank except when referring to their personal retirement actions."

Revised paragraph 6-7 ("Army Reserve personnel not on active duty") now reads as follows: "Army reservists not on active duty are governed by the same rules as personnel on active duty. Exception: Add the identification 'USAR' after the grade of enlisted personnel or the branch assignment of commissioned officers. General officers, chaplains, and warrant officers will also use USAR."

Revised paragraph 6-11 ("Addressing retired military") now reads as follows:

- "a. When addressing Army retired military personnel, show their grade, name, title of the Service, and the word 'Retired' (for example, Colonel A .B. Smith, USA Retired; or MAJ Edward A. Dees, USA Retired). The abbreviated form of retired (Ret) may be used, but use the entire word if the signer wishes.
- b. When addressing Army correspondence to retired military personnel of other Services, show their grade, name, title of the Service, and the word 'Retired' (for example, Lt Col A. B. Smith, USAF Retired)."
