the state highway system as the "U.S. Army 77th Infantry D
Expressway"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND
BLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The highway law is amended by adding a new section 3
2 read as follows:
3 S 343-O. PORTION OF THE STATE HIGHWAY SYSTEM TO BE DESIGNATED
4 "U.S. ARMY 77TH INFANTRY DIVISION EXPRESSWAY". ALL THAT PORTION
5 STATE HIGHWAY SYSTEM WHICH IS IDENTIFIED AND KNOWN AS THE CI
6 EXPRESSWAY (INTERSTATE 295), SHALL BE DESIGNATED AND KNOWN AS THE
7 ARMY 77TH INFANTRY DIVISION EXPRESSWAY".
8 S 2. The commissioner of transportation shall provide for the
9 lation and maintenance of adequate signing of the state highway
10 as designated pursuant to section one of this act. However, t

12 designation called for pursuant to this act shall be one of cer
13 nature and the official name of such expressway shall not be cha
14 a result of this act.
15 S 3. This act shall take effect immediately.
